Who We Are

Flying Elephant Films Limited is an independent film production company based in the United Kingdom. We develop and produce feature films, documentaries, and other audiovisual content, working with contributors, collaborators, partners, and audiences across a range of projects.

As part of our work, we may collect and process personal data. We are committed to doing so responsibly, transparently, and in accordance with applicable data protection laws, including the UK General Data Protection Regulation (UK GDPR).

What Personal Data We Collect

Depending on your interaction with us, we may collect the following types of information:

- **Contact Information:** name, email address, phone number
- **Professional Information:** CVs, portfolios, employment history, credits
- **Project-related Information:** contributions, interviews, recordings, and associated metadata
- **Financial Information:** payment details for services rendered
- **Technical Data:** website usage data, cookies, IP address

In certain cases, we may collect **special category data** (e.g. health information or personal experiences shared as part of documentary storytelling). This will only be done where necessary and with your explicit consent.

Why We Collect Personal Data

We collect and process personal data for the following purposes:

- To develop, produce and distribute film and media content
- To communicate with contributors, collaborators, and partners
- To manage casting, recruitment, and project participation
- To administer contracts, payments, and production logistics
- To respond to enquiries and maintain professional relationships
- To comply with legal and regulatory obligations

How We Collect Data

We collect personal data through:

- Direct interactions (emails, forms, meetings, interviews)
- Participation in productions or projects
- Submissions (e.g. CVs, showreels, proposals)
- Third-party service providers (e.g. payment platforms)
- Website usage (via cookies and analytics tools)

We will always make clear what data is being collected and why.

Consent and Your Rights

Where we rely on your consent to process data, you have the right to withdraw it at any time.

You also have the right to:

- Access the personal data we hold about you
- Request correction of inaccurate data
- Request deletion of your data (where applicable)
- Restrict or object to processing
- Request transfer of your data (data portability)

To exercise any of these rights, please contact us via email.

How We Store and Protect Data

We take data protection seriously and implement appropriate technical and organisational measures to safeguard your information.

- Data is stored securely on protected systems
- Access is restricted to authorised personnel only
- We use secure platforms for communication and storage
- We regularly review our data protection practices

How We Share Personal Data

We may share your data where necessary with:

- Production partners, broadcasters, and distributors
- Professional collaborators (e.g. crew, editors, legal advisors)
- Service providers (e.g. payment processors, IT services)
- Regulatory authorities or legal bodies where required

We will only share data where it is necessary, lawful, and proportionate.

How Long We Keep Your Data

We retain personal data only for as long as necessary for the purposes for which it was collected, including:

- Duration of a project or collaboration
- Legal, contractual, or financial obligations
- Archival purposes related to film production
